Recurring monthly subscription rate

You authorize regularly scheduled charges to your checking or savings account. Per your authorization below, **Centerforward Web Services, LLC (CWS)** will collect \$349.99 on the first of each month to automatically continue your **lcbasel** service subscription. A receipt for each payment will be emailed to you and the charge will appear on your bank statement as an "ACH Debit." For your very first six months of service, your subscription is **month-to-month** and you may cancel for any reason before **5 business days** from the next month.
